Distinguished Guests,

***** Ladies and Gentlemen,

Good evening!

- 1. It is my great honour to join you all here today for the closing ceremony of the 16th Association of Insurance Brokers of Kenya (AIBK) Annual Regional Conference which has brought together insurance and other financial services sector players to deliberate on issues that will affect not only your industry, but will have a bearing in the financial planning of the country.

- 6. This is a deliberate strategy, in the realization that to have the desired impact, we must seal the spaces in which criminal networks may exploit to pursue their misadventures.
- 7. As such we are keen in sealing loopholes exploited to undertake money laundering and fraud, specifically where public resources are involved. This is because the insurance sector is among those identified as vulnerable to these financial crimes.
- 8. It is my expectation that these challenges and vulnerabilities facing the insurance sector were discussed and proposals made towards their mitigation.
- 9. I note that data protection laws were also identified among the risks that impact the insurance sector and that concrete suggestions have been made on how the sector may safeguard breach of data in their custody as well as how they could utilize data to analyse the inherent risks associated with the industry to crime.

Ladies and Gentlemen,

- 10. There are numerous benefits to strengthening the relationship between the private and the public sector. We must acknowledge that a stronger relationship is much more capable of bringing about major social and economic changes.
- 11. As I conclude, I would once again like to thank the AIBK for organising and hosting this conference.
- 12. Keeping with the theme of this year's conference, I hope that we are able to further evolve our relationship and bridge the gap between the private and public sector so that we can build a better nation.
